Important changes to the professional advisory committee (WAHPC) to Welsh Government

CAHPA Ruth Crowder talked to the Board about the changes being brought forward for the Welsh AHP advisory machinery to Welsh Government. A new slimmed down executive committee will have just 8 members which will act as an organising committee. This committee will work with a new AHP forum which will be known as the 'AHP Network.' Groups that meet on an all-Wales basis or hold a regular forum in Wales are invited to register a lead contact in order to provide Welsh Government with a wide range of groups, across professions, that they can tap into. It is likely that there will be one big meeting/year for the AHP Network and it may be that events are set up around specific areas as required, for example, Children's Services.

This way, your speciality area will be part of the AHP Network.
